RESOLUTION NO. 22-06

**RESOLUTION OF THE TRI-COUNTY WATER AUTHORITY APPROVING THE
LEVYING OF 2023 PUMP FEE**

WHEREAS, the Tri-County Water Authority (the “Authority”) is a joint powers authority, formed pursuant to the Joint Exercise of Powers Act (Gov. Code §§ 6500 *et seq.*); and

WHEREAS, pursuant to the Sustainable Groundwater Management Act (“SGMA”), the Authority is also an exclusive Groundwater Sustainability Agency (“GSA”) in a portion of the Tule Subbasin and a portion of the Tulare Lake Subbasin (Subbasins 5-22.13 and 5-22.12, respectively, of the San Joaquin Valley Basin as defined by California Department of Water Resources Bulletin 118) underlying the Authority’s boundaries; and

WHEREAS, California Water Code Section 10730 provides that, as a GSA, the Authority may levy fees or assessments in compliance with Proposition 218 as specified in Article XIID of the California Constitution; and

WHEREAS, on December 18, 2019, the Authority did adopt a commissioned rate study setting forth the need for the imposition of a groundwater extraction fee of up to TEN AND 00/100 DOLLARS (\$10.00) per acre-foot extracted (the “Fee”), which Fee is based upon the cost of the Authority’s provision of services (the “Services”) in proportion to the cost of rendering such services to each affected landowner for the purpose of monitoring and limiting groundwater extraction to sustainable yield in accordance with the requirements of SGMA; and

WHEREAS, following the adoption of the rate study, the Authority did, in accordance with the requirements of Proposition 218, timely mail notice of a public hearing regarding implementation of the Fee to all affected landowners of record located within the Authority’s boundaries; and

WHEREAS, on March 5, 2020, the Authority did hold a public hearing in order to receive public comment and protests on the Authority’s intended implementation of the Fee, at which hearing less than fifty percent (50%) of the potentially affected landowners subject to the Fee submitted a written protest against said Fee; and

WHEREAS, on November 5, 2020, having met the requirements set forth in Proposition 218 for the imposition of the Fee, the Board of Directors (the “Board”) of the Authority did authorize a Fee of TEN AND 00/100 DOLLARS (\$10.00) per acre-foot of groundwater extracted for the 2021 calendar year; and

WHEREAS, on February 18, 2021, pursuant to powers granted under Water Code §§10725 *et seq.*, the Board did vote to adopt the Authority’s Policy and Procedures for Groundwater Extraction Allocation (the “Policy”) in furtherance of its management of groundwater usage within the Authority’s boundaries; and

WHEREAS, the Board has determined, after due consideration of the continuing and projected costs related to the Authority's provision of the Services, that the Fee shall remain TEN AND 00/100 DOLLARS (\$10.00) per acre-foot for groundwater extraction within sustainable yield limits for the 2023 calendar year; and

WHEREAS, the Board has determined that the Policy, as amended from time-to-time, remains in effect and enforceable.

NOW, THEREFORE, THE BOARD OF DIRECTORS OF THE TRI-COUNTY WATER AUTHORITY does hereby resolve, declare and order as follows:

1. The above Recitals are deemed true and correct and are incorporated herein by this reference.
2. The Board of Directors of the Authority hereby sets the 2023 groundwater extraction fee at TEN AND 00/100 DOLLARS (\$10.00) per acre-foot for groundwater extraction within sustainable yield limits.
3. The Authority hereby directs and authorizes its consultants/staff to collect the groundwater extraction fee on the Authority's behalf for the 2023 year.
4. Authority consultants/staff are authorized and directed to complete the necessary documentation to levy the Authority's 2023 groundwater extraction fee.
5. Authority consultants/staff are authorized and directed to continue to enforce the Policy, as it may be amended from time-to-time.
