- 6. Review and consider action to participate in the Land Fallowing and Cover Cropping Pilot Program sponsored by the Tule Basin Land & Water Conservation Trust and The Nature Conservancy.

Executive Director Susan Long from the Tule Trust reviewed the program being offered to landowners. In its second year, the program was well received in two of the other GSAs and saved approximately 3,000 AF of water. Applications for the new year are being accepted until September 15 and the financial commitment by TCWA would be \$125,000 with matching funds from outside sources. The funds would only be requested once the landowner’s application (a one-year commitment) has been accepted. No up-front money is required and to be eligible, the land needs to have been irrigated in the prior three years.

7. Update for Tule and Tulare Lake Subbasins Inadequate determinations by DWR.

Amer Hussain from Geosyntec provided an update on both the Tule and Tulare Lake Subbasins and the work being done prior to Probationary Hearings. There is currently no date set for the first hearing, however it is anticipated to be in February or March, 2024. Revisions to the GSP are being worked on and it is expected to have completion by end-of-year. Minimum thresholds will need to be modified, pumping reductions implemented, and it may be that the Tule Subbasin will only have one GSP instead of the individual plans that it currently has. From previous meetings with staff at the State Board, the understanding is that the timeline for achieving sustainability has been moved up.
